Effective: October 1, 2022

This filing is made in compliance with Ordering Clause No. 3 of the Order which directed the Company to file tariff amendments to incorporate revisions to the Expanded Solar for All (“E-SFA”) program, on not less than five days’ notice, to become effective on a temporary basis on October 1, 2022. The changes modify the E-SFA program such that customers automatically enrolled in the E-SFA program may simultaneously subscribe to a Community Distributed Generation (“CDG”), Remote Crediting (“RC”), or Remote Net Metered (“RNM”) project. The Commission’s existing policy prohibiting a customer from simultaneously subscribing to multiple CDG projects, or to simultaneously enroll in a CDG project and a RC or RNM project, shall remain in place. Attachment A to this filing contains the redlined tariff leaves for these amendments.

In addition to the tariff revisions required by the Order, the Company is including additional tariff revisions to Rule 29.5 for the program, following consultation with Department of Public Service (“DPS”) Staff, to clarify the language of various tariff provisions and to increase the time given to a CDG project to submit their Project Participation Form from thirty (30) days to sixty (60) days.

In accordance with Ordering Clause No. 4 of the Order, the requirements of PSL 66(12) (b) and 16 NYCRR §720.8.1 concerning newspaper publication of the proposed tariff amendments described in Ordering Clause No. 3 are waived.
