Purpose of Filing

The Companies are filing amendments to its tariffs in compliance with Ordering Clause No. 1 of the Order to implement the Late Payment Charge and Other Waived Fees ("LPCO") Surcharge, consistent with the body of the Order.

The Companies are implementing a surcharge to collect the unbilled fees from all electric and natural gas customers with the exception of electric customers that qualified and received an allocation from the New York Power Authority¹.

Newspaper Publication

In accordance with Ordering Clause No. 2, the requirements of Public Service Law §66(12)(b) and 16 NYCRR §720-8.1 to be completed prior to the effective date are waived. The Companies will complete newspaper publication and provide proof of notice has been published for four successive weeks.

¹ In accordance with the Companies' tariffs, customers that qualify for and receive an allocation of Western New York NYPA Power are exempt from the Transition Charge (Non-bypassable charge). Customers with an allocation of Recharge New York power are not exempt from the Transition Charge and will be subject to the LPCO Surcharge.
