**RE: Case 19-G-0309 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of The Brooklyn Union Gas Company d/b/a National Grid NY for Gas Service.**

**Gas Safety and Reliability Surcharge (“GSRS”) for Brooklyn Union Gas Company d/b/a National Grid**

Dear Secretary Phillips:

The Brooklyn Union Gas Company d/b/a National Grid NY (the “Company”) hereby submits its Statement of Gas Safety and Reliability Surcharge (“GSRS”) in compliance with Rule 51 of its tariff, PSC No. 12 – Gas and Section 3.10 of the Joint Proposal adopted by the New York State Public Service Commission in its order dated August 12, 2021 (the “Order”) in the above-referenced matter.

The KEDNY leak prone pipe (“LPP”) retirement figure represents LPP retirement footage completed between April 1, 2021 and March 31, 2022. These projects are in various stages of closeout and certain of the projects submitted as part of this filing have “design” footage in place of “actual” footage until final closeout of project documentation occurs. “Design” footage represents a conservative estimate of the LPP retirement and, therefore, final closeout commonly results in the increase of LPP footage claimed per project. Once these remaining projects are closed out, the Company will determine the actual LPP footage for each project. For this reason, final closeout of all calendar year (“CY”) 2021 documentation may require an adjustment of the claimed LPP retirement footage in the following year’s annual filing.

This filing uses the rate allowance levels approved in Case 19-G-0309. The Company has calculated the GSRS related to the period April 1, 2021 through March 31, 2022, including prior year total imbalance. Effective July 1, 2022 through June 30, 2023, the following GSRS will be implemented:

- Service Classification Nos. 1A, 1AR, 1B, 1BI, 1BR, 1B-DG, 2-1, 2-2, 3, 4A, 4A-CNG, 4B, 7, 17 and 21: \$0.0001 per therm.

Attachment 1 contains the calculations used to develop the GSRS.

Because the GSRS rate is one of the components included in the Statement of Delivery Rate Adjustment ("DRA"), the DRA statement will be filed once all July 1<sup>st</sup> rate statements have been submitted.
