RE: Case 20-E-0380 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Niagara Mohawk Power Corporation d/b/a National Grid for Electric Service

Dear Secretary Phillips:

In accordance with the *Order Adopting Terms of Joint Proposal, Establishing Rate Plans and Reporting Requirements* (issued and effective January 20, 2022) in Cases 20-E-0380 and 20-G-0381 (the “Order”), Niagara Mohawk Power Corporation d/b/a National Grid (the “Company”) submits for filing the P.S.C. No. 214 – Outdoor Lighting tariff leaves listed on Attachment A. Specifically, Ordering Clause No. 5 directed the Company to file, on not less than 30 days’ notice, tariff revisions necessary to effectuate the provisions adopted by the Order for Rate Year Two, the twelve-month period ending June 30, 2023, to take effect on a temporary basis on July 1, 2022.

Per Ordering Clause No. 6 of the Order and as required by Public Service Law §66(12)(b), the volumetric rates set forth in the revised tariff leaves for Rate Year 2 will be published in newspapers in the Company’s service territory. The Company will file proof of publication with the Commission once all publications have been made.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission’s Codes, Rules and Regulations (16 NYCRR, Appendix 7-H). As required by the Order, the Active Parties to Case 20-E-0380 have been copied on this filing.
