Statement of Demand Response Incentive Rates No. 1

To P.S.C. No 12-GAS

The purpose of this filing is to comply with Clause No. 2 on page 15 of the Order which directed the Company to file tariff amendments to be effective on November 1, 2021 on not less than five days' notice. These tariff amendments include several revisions required by the Commission in the Order as follows:

- 1) Include a "Definitions" section;
- 2) Remove example calculations;
- 3) Remove specific reference to Winter 2021/2022;
- 4) Clarify that customers participating in Daily DR Program Options 3 and 4 must participate in both the morning and evening Event hours, if the Company calls upon them to do so;
- 5) Include the residential firm demand response programs.

Per Clause No. 3 on page 15 of the Order, the Commission waived the newspaper publication requirements of § 66(12) of the Public Service Law and 16 NYCRR 270.70 for the tariff amendments.
