In connection with this filing, the Company is also required to submit information that contains trade secrets. Accordingly, the Company has filed the required information with the Records Access Officer, together with a request for trade secret protection under the Commission's regulation.

The Company's Annual Reconciliation of Gas Cost and its System Performance Adjustment Mechanism for the twelve months ended August 31, 2023 were filed on October 13, 2023 in Case 22-G-0464. The workpapers supporting the rates effective January 1, 2024 through December 31, 2024 are also included in this filing.

The calculation for the Research and Development Funding Mechanism pursuant to Commission Order in Case 04-G-1047 is included as a workpaper. The unit surcharge of \$0.0096/Mcf is applicable for the period January 1, 2024 through December 31, 2024.

CIP Statement No. 81 was filed on December 15, 2023 in Case 18-M-0084. The CIP filing workpapers for the rates effective January 1, 2024 through December 31, 2024 have been included along with the workpapers referenced above.
