RE: Case 18-E-0138 – Proceeding on Motion of the Commission Regarding Electric Vehicle Supply Equipment and Infrastructure.

Dear Secretary Phillips:

In accordance with the *Order Approving Midpoint Review Whitepaper's Recommendations with Modifications* (issued and effective November 16, 2023) in the above proceeding (the Order), Niagara Mohawk Power Corporation d/b/a National Grid (the Company) submits the following tariff leaves:

Eighth Leaf No. 220  
Seventh Leaf No. 236

To P.S.C. 220 Electricity

Effective: January 1, 2024

Ordering Clause No. 25 of the Order directs the Company to file tariff revisions to reflect the eligibility of vehicle to grid integration under the Value of Distributed Energy Resources (VDER) Value Stack tariff. While the P.S.C. 220 Electricity tariff currently includes vehicle-to-grid (V2G) as Value Stack eligible, the Company has added language under Rule 40.2 to include vehicle-to-grid integration (VGI) as an eligible stand-alone storage technology. Furthermore, Ordering Clause No. 35 of the Order directs the Company to file tariff revisions, as necessary, to effectuate the provisions directed in the Order. The Company has amended Rule 52 – Electric Vehicle Make-Ready Surcharge to recover Micromobility Make-Ready Program costs in the surcharge.

Both Ordering Clauses specify the tariff amendments be filed on not less than 30 days' notice become effective on January 1, 2024. Ordering Clause No. 36 of the Order waived the requirements of Public Service Law § 66-12-b and 16 NYCRR § 720-8.1 concerning newspaper publication of the tariff filings in Ordering Clause Nos. 25 and 35.
