These leaves are being filed in compliance with the Commission's Order dated October 28, 1999 in the aforementioned case. The leaves reflect the following revisions:

1. The imposition of a \$20.00 fee (excluding taxes) for residential and non-residential sales customers who request that their meters be read on a date other than their regularly scheduled meter reading date.

2. The removal of the proposed "Electronic Check Payment" section.
3. The imposition of a \$13.88 fee (excluding taxes) to owners (landlords) for each posting of a termination notice for nonpayment in the public areas of a multiple dwelling that the Company makes.
4. The reduction of the fee for providing customer billing information from \$33 to \$15.
5. A nominal increase to the minimum charge applicable to S.C. Nos. 1A, 1B, 2, 3, 4A, 4B, 16 and 17 of .02 - .04¢ to recover the additional revenue deficiency caused by the increase in the number of eligible customers under the Company's low-income rates (S.C. Nos. 1AR and 1BR) from 37,000 to 42,000.
