The enclosed revised leaves, issued by New York State Electric & Gas Corporation ("NYSEG" or the "Company"), are transmitted for filing in compliance with the requirements of the Public Service Commission, State of New York.

Proposed Revisions

The proposed revisions are being submitted pursuant to the Commission's Order Adopting Permanent Rule (the "Order"), issued January 31, 2001 in Case 00-G-0996. This filing reflects the modification of the noncompliance provisions as set forth in the Order. Specifically, revisions are being made to increase the premium associated with noncompliance from 110% to 130%. In addition, revisions are being made to apply the premium for the billing period during which noncompliance becomes known, and for any subsequent periods during which noncompliance continues.

Reasons for Proposed Revisions

The proposed revisions are being submitted in compliance with the Commission's Order Directing Utilities To File Revised Interruptible Gas Service Tariffs, issued August 24, 2000 in Case 00-G-0996 and the Commission's Order Adopting Permanent Rule, issued January 31, 2001 in Case 00-G-0996 (collectively, the "Orders").

Background

On June 21, 2000 the Commission proposed to require that jurisdictional utilities revise their procedures to help insure that interruptible customers are prepared for potential service interruptions. In addition, the Commission sought comments on their proposal to require interruptible customers to have a certain amount of alternative fuel on hand and that utility tariffs be revised to include a higher rate for customers that failed to comply with the revised requirements. Subsequently, the Commission's Order Directing Utilities To File Revised Interruptible Gas Service Tariffs was issued August 24, 2000 in Case 00-G-0996.

NYSEG filed revised and original tariff leaves in compliance with the Order on September 5, 2000, September 14, 2000 and September 29, 2000 (collectively, the "Filings"). In the Filings, NYSEG proposed revisions to

Interruptible Sales Service, Service Classification No. 3 of PSC No. 87 Gas, Interruptible Transportation Service, Service Classification No. 2 of PSC No. 88 Gas, Incremental Interruptible Transportation Service, Service Classification No. 3 of PSC No. 88 Gas and Basic Electric Generation Service, Service Classification No. 15 of PSC No. 88 Gas.

Newspaper Publication & SAPA

Pursuant to Ordering Clause No. 1 of the Commission's August 24, 2000 order, the requirement of Section 66(12)(b) of the Public Service Law as to newspaper publication has been waived.
