### **Reasons for Proposed Revisions**

The Public Service Commission developed a new procedure for filing tariffs electronically. To start the new Electronic Tariff System (ETS), it is necessary for New York State utilities to cancel their current schedule(s) and submit new ones formatted for the ETS. On December 20, 1996, NYSEG filed Schedule PSC No. 88 to supersede P.S.C. No. 83. PSC No. 88 became effective on March 7, 1997. During the period from December 20, 1996 to March 7, 1997, NYSEG filed a revised Addendum to P.S.C. No. 83 and updated its Service Agreement for Repackaged Gas Services, therefore, it is necessary to incorporate those revisions into the new tariff, PSC No. 88, to bring it up-to-date. Further, typographical errors were found in General Information Section No. 18 and are being corrected at this time.

### **Proposed Revisions**

On January 23, 1997, NYSEG filed a revised Addendum to P.S.C. No. 83 to revise the data for Customer No. 1 and that revision is now being made on the Addendum to the new tariff, PSC No. 88. Also, the

Service Agreement for Repackaged Gas Services in General Information Section 19 is being revised to reflect the change in the tariff number from P.S.C. No. 83 to PSC No. 88, to incorporate changes that have been made to the Agreement since its inception, and to add "Exhibit A" to the Agreement. These changes do not change the service being provided to the customer. Finally, typographical errors found in General Information Section No. 18 are being corrected.

**Customer Impact Assessment**

Since these revisions are "housekeeping" in nature, there will be no customer impact.

**Newspaper Publication & SAPA**

NYSEG requests waiver of publication of this proposed change in accordance with 16 NYCRR Part 270.70, as this "housekeeping" revision has NO direct impact to NYSEG's gas customers.

**Special Requests**

NYSEG requests a waiver from the applicable sections of 16 NYCRR Part 270 to allow for the new electronic format.
