Dear Secretary Deixler:

Enclosed for filing with the Public Service Commission ("the Commission") are revised scheduled leaves issued by Consolidated Edison Company of New York, Inc. ("Con Edison" or "the Company") to reflect a revision to Con Edison's Schedule for Gas Service, P.S.C. No. 9 – Gas as identified in Appendix A.

The tariff leaves bear an issue date of May 17, 2002, an effective date of May 20, 2002, and a notification that the leaves are issued in compliance with the Commission's order dated April 22, 2002 ("April 22 order") in the subject case numbers.

The tariff revisions reflect minor word omissions and deletions excluded from the tariff leaves issued on April 29, 2002 and effective on May 1, 2002 that were issued in compliance with the April 22 order. For example, some leaves still make reference to Capacity Balancing

Service which was eliminated; such references have been deleted. Additional language has been added to other leaves, clarifying that the new monthly Gas Cost Factor is applicable to SC Nos. 1, 2, 3 and 13.
