Reasons for Proposed Revisions

This filing is being submitted to make "housekeeping" revisions to NYSEG's gas tariffs.

Proposed Revisions

<u>Third Revised Leaf No. 7 to PSC No. 87</u> - Add the Towns of Romulus and Varick to the Seneca County section of "Territory To Which Schedule Applies". NYSEG was granted permission to exercise gas franchises in these towns in Case No. 00-G-0670 by Order dated June 21, 2000.

Fourth Revised Leaf No. 9 to PSC No. 87 - Add the Town of Peru to the Clinton County section of "Territory To Which Schedule Applies". NYSEG was granted permission to exercise a gas franchise in this town in Case No. 99-G-1812 by Order dated April 20, 2000.

<u>Eighth Revised Leaf No. 2 to PSC No. 88</u> - Correct the leaf number reference for Item 4. - Daily Metered Transportation Requirements.

<u>Fifth Revised Leaf No. 3 to PSC No. 88</u> - Correct the leaf number reference for Item 20. - Non-Performance and Marketer Conditions of Service and add Item 32 - Consolidated Billing and Paynment Processing, which was inadvertently omitted in a previous filing.

Second Revised Leaf No. 75 to PSC No. 88 - Remove the "Terms of Payment" clause. This clause is a duplicate as it also appears on Leaf No. 74.

Third Revised Leaf No. 89 to PSC No. 90 - Correct the letter designation of "Definition of Costs" from B. to G. to obtain proper alaphabetical sequence of the sub-sections.
