Reasons for Proposed Revisions

This "housekeeping" filing is being submitted to bring NYSEG's gas tariffs up-to-date and to revised incorrect tariff language and references.

Proposed Revisions

The Company proposes to revise its gas tariffs to: (1) include new gas franchises to the "Territory to Which Schedule Applies" section of the tariff; (2) add the Village of Lowville to the RTS Statements; (3) revise all tariff references to reflect the new Schedule numbers, PSC No. 89 and PSC No. 90, formerly PSC No. 84 and PSC No. 30, respectively; (4) correct other wording as necessary to ensure consistency throughout the tariffs. Similar revisions were submitted during the conversion of the tariffs to electronic format, however, several changes were missed at that time and are being corrected at this time; (5) removal of tariff language that is obsolete but was not removed during previous filings; and (6) correction of typographical errors.

Customer Impact Assessment

These revisions will have no impact on NYSEG's gas customers.

Newspaper Publication & SAPA

NYSEG requests waiver of publication of this proposed change in accordance with 16 NYCRR Part 270.70, as these "housekeeping" revisions have NO direct impact to NYSEG's gas customers.

NYSEG requests a waiver from the applicable sections of 16 NYCRR Part 270 to allow for the new electronic format.
