On October 28, 1998, a copy of this filing will be mailed to all active parties in Case 98-G-1291. This list is shown on Attachment A. Also included is Statement No. 1, Statement of Revenue Credits.

Sample bill comparisons, comparisons of the decrease by rate schedule and rate design workpapers will be distributed by separate letter.

The Company proposes not to file an interim GAC effective October 29, 1998 for the new base cost of gas and fixed factor of adjustment. If such an interim GAC were filed, it would be in effect only two days as the monthly GAC is subsequently filed for an effective date of November 1, 1998. The Company has calculated the impact of this two day interim GAC, on the two billing controls that would be affected to be approximately \$4,500.00. In the interest of administrative efficiency, the Company will file its normal GAC effective November 1, 1998 with the new rates reflected in that calculation.

The Order states rates will become effective retroactively to October 1, 1998. On November 3, 1998 the Company will adjust bills for the rate difference between the rates that were previously billed effective October 1, 1998 and the rates effective October 29, 1998 in Case 98-G-1291. A one time adjustment will appear on the customer*s bill during November and December 1998 billings.

Notice to the public of the proposed change will be published once a week for four successive weeks, and proof of publication shall be filed with the Commission.
