Reasons for Tariff Changes

In compliance with the Commission's September 22, 1999 order (Case No. 98-M-1343) Con Edison is filing today electronically changes to its gas tariff.

The Company filed corresponding revisions to its Gas Sales and Transportation Operating Procedures yesterday via overnight mail.

With respect to the temporary waiver granted to the Company by the May 20, 1999 Order for the provision of interval data for interruptible and off-peak firm gas sales customers, the Company has reviewed computer system changes and finds that it needs additional time to implement the changes required to be able to supply such information. Therefore, the Company respectfully requests that the waiver be extended to February 1, 2000.
