Dear Acting Secretary Renner:

Enclosed for filing with the Public Service Commission ("the Commission ") are revised schedule leaves issued by Consolidated Edison Company of New York, Inc. ("Con Edison" or "the Company") to reflect revisions to the Company's Schedule for Gas Service, P.S.C. No. 9 - Gas. Appendix A identifies the leaves being revised. This filing conforms the Company's P.S.C. No. 9 gas tariff to revisions that were made to the Company's P.S.C. 8 gas tariff that become effective on December 18, 1998 concerning veterans' organizations.

The tariff leaves are issued July 29, 1999 to become effective September 1, 1999 or on such earlier date as the Commission may, by order, approve.

**Reasons for Tariff Changes**

On November 18, 1998 the Company filed tariff revisions to its P.S.C. No. 8 Gas tariff and to its P.S.C. No. 9 Electric tariff to

reflect enacted legislation concerning rates charged to veterans' organizations. These tariff revisions became effective December 18, 1998 on an emergency basis and were approved on a permanent basis on March 12, 1999.

In November of 1998 the Company also submitted to the Commission a new reformatted gas tariff designated as P.S.C. No. 9 - Gas to accommodate electronic filings. The changes referenced above were not contained in that filing. The P.S.C. No. 9 gas tariff became effective March 1, 1999. The instant filing incorporates the revisions made to PSC No. 8 - Gas for veterans' organizations into the Company's currently effective tariff P.S.C. No. 9 - Gas.
