Statement of System Benefit Charge: Statement No. 2

To PSC No. 214 Electricity

Effective: September 1, 1999

Description of Filing

This filing constitutes the Company's compliance with certain of the Commission's directives associated with the implementation of the PowerChoice Settlement Agreement, filed on October 10, 1997, and as further modified by the Commission. Specifically, the PowerChoice Settlement Agreement's Section 4.15 - Annual Tariff Filings stated that during the term of the Agreement the Company should make annual tariff filings to be effective on each anniversary of the PowerChoice Implementation Date (PID). The initial PID was September 1, 1998. Section 4.15 also states that the annual filings should be issued to the Commission approximately 120 days prior to the effective date and should reflect the terms of the Agreement. Accordingly, this filing proposes PSC No. 214 Electricity prices for the second year of the Agreement's term, September 1, 1999 through August 31, 2000.

Proposed Unbundled Prices for P.S.C. No. 214 Electricity

The proposed electric rate designs included with this filing were performed to comport with Opinion No. 98-8 for conditions associated with the second year of the Settlement Agreement's term.

Exhibits that support the PSC No. 214 service classifications' rate designs are included with the filing submitted to the Commission on May 4, 1999 that propose to update prices for the second year of the Agreement's terms for PSC No. 207 Electricity.

System Benefits Charge Statement

Included with this filing is the System Benefits Charge (SBC) Statement No. 2 effective September 1, 1999. This statement is being made in compliance with Rule No. 41 of P.S.C. No. 207 Electricity, and Section 4, Paragraph 4.3.4 and Section 7 of the PowerChoice Settlement Agreement.

Newspaper publication will be made in accordance with 16NYCRR 136.70 on May 19 and May 26 and June 3 and June 10, 1999.
