Proposed Revisions

NYSEG proposes to revise the requirements applicable to distillate fuel and human needs customers receiving Incremental Interruptible Transportation Service, Service Classification No. 3 of PSC No. 88 Gas. The proposed revisions are being submitted as an amendment to NYSEG's September 5, 2000 filing (the "Filing") in Case No. 00-G-0996. The proposed revisions are consistent with those submitted in the Filing for Interruptible Sales Service, Service Classification No. 3 of PSC No. 87 Gas and Interruptible Transportation Service, Service Classification No. 2 of PSC No. 88 Gas.

Reasons for Proposed Revisions

The proposed revisions are being submitted in compliance with the Commission's <u>Order Directing Utilities To File Revised Interruptible Gas</u>
<u>Service Tariffs</u> (the "Order"), issued August 24, 2000 in Case 00-G-0996.

Background

On June 21, 2000 the Commission proposed to require that jurisdictional utilities revise their procedures to help insure that interruptible customers are prepared for potential service interruptions. In addition, the Commission sought comments on their proposal to require interruptible customers to have a certain amount of alternative fuel on hand and that utility tariffs be revised to include a higher rate for customers that failed to comply with the revised requirements. Subsequently, the Commission's Order Directing Utilities To File Revised Interruptible Gas Service Tariffs was issued August 24, 2000 in Case 00-G-0996.

NYSEG filed revised and original tariff leaves in compliance with the Order. In the Filing, NYSEG proposed revisions to Interruptible Sales Service, Service Classification No. 3 of PSC No. 87 Gas and Interruptible Transportation Service, Service Classification No. 2 of PSC No. 88 Gas. However, NYSEG failed to submit revisions for Incremental Interruptible

Transportation Service, Service Classification No. 3 of PSC No. 88 Gas.
