Proposed Revisions

The proposed revisions are being submitted as an amendment to NYSEG's September 5, 2000 and September 14, 2000 filings (the "Filings") in Case No. 00-G-0996. NYSEG's proposed modifications reflect certain changes and modifications as discussed with Staff.

Specifically, the filing reflects the following:

- (1) Consistent with the provisions contained in the previous Filings, Basic Electric Generation Service, Service Classification No. 15, leaves 109 through 111 have been revised to incorporate requirements for distillate fuel customers.
- (2) Leaves 27, 61.1 and 64.1 have been revised to reflect that customers will have one business day to comply with the Company's request to inspect facilities. Customers failing to comply with the request will be subject to the pricing premium established for non-compliance.
- (3) Leaves 26, 61 and 64 have been revised to replace the word "penalty" with the word "charge"

Reasons for Proposed Revisions

The proposed revisions are being submitted in compliance with the Commission's Order Directing Utilities To File Revised Interruptible Gas Service Tariffs (the "Order"), issued August 24, 2000 in Case 00-G-0996.

Background

On June 21, 2000 the Commission proposed to require that jurisdictional utilities revise their procedures to help insure that interruptible customers are prepared for potential service interruptions. In addition, the Commission sought comments on their proposal to require interruptible customers to have a certain amount of alternative fuel on hand and that utility tariffs be revised to include a higher rate for customers that failed to comply with the revised requirements. Subsequently, the Commission's Order Directing Utilities To File Revised Interruptible Gas Service Tariffs was issued August 24, 2000 in Case 00-G-0996.

NYSEG filed revised and original tariff leaves in compliance with the Order. In the Filings, NYSEG proposed revisions to Interruptible Sales Service, Service Classification No. 3 of PSC No. 87 Gas, Interruptible Transportation Service, Service Classification No. 2 of PSC No. 88 Gas and Incremental Interruptible Transportation Service, Service Classification No. 3 of PSC No. 88 Gas.

Newspaper Publication & SAPA

Pursuant to Ordering Clause No. 1 of the Commission's August 24, 2000 order, the requirement of Section 66(12)(b) of the Public Service Law as to newspaper publication has been waived.
