**Re: Case 07-M-0548, Energy Efficiency Portfolio Standard**

Dear Secretary Brillling:

Enclosed for filing with the New York State Public Service Commission (the "Commission") are revised schedule leaves issued by Consolidated Edison Company of New York, Inc. ("Company") applicable to its customers in the City of New York and the County of Westchester. This filing reflects revisions to the Company's Schedule for Gas Service, P.S.C. No. 9 –Gas (the "Gas Tariff")

The tariff leaves reflecting the proposed revisions are identified in the table below:

The leaves are issued September 29, 2008 to be effective on October 1, 2008.

**Reason for the Proposed Tariff Modifications**

By letter dated July 31, 2008, the Company filed tariff amendments in accordance with the Commission's Order Establishing Energy Efficiency Portfolio Standard and Approving Programs issued and effective June 23, 2008, in Case 07-M-0548, (the "Energy Efficiency Order") establishing a gas System Benefits Charge ("SBC").

An errata notice to the Energy Efficiency Order was issued on July 3, 2008 correcting errors in Table 18 on page 18 of Appendix 1. As a result, the Company is making the following tariff changes:

- For the period October 1, 2008 through December 31, 2008, the amount expected to be collected through the SBC has been changed from \$1,084,472 to \$1,068,170.
- For each annual period thereafter, commencing January 1, 2009, the amount expected to be collected through the SBC has changed from \$4,337,887 to \$4,272,679.

In addition, the Company is making tariff changes as follows:

- The following leaves have been amended to include either a reference to or an explanation of the System Benefits Charge: 5, 154.9, 154.18, 154.24, 182, 183, 228, 231, 240, 255, 303.1, and 349. These changes were included in the July 31, 2008 filing but were removed in an August 29, 2008 compliance filing in Case 06-G-1332.
- The following leaves include minor housekeeping changes: 5, 6, 255, and 303.1.

Attached to this filing is a Statement of System Benefits Charge applicable to firm sales and firm transportation customers.

### **Conclusion**

In accordance with Ordering Clause 6 of the Energy Efficiency Order, the requirements of Section 66(12)(b) of the Public Service Law as to newspaper publication of the changes proposed by the tariff amendments are waived.
