Re: Case No. 03-E-0765 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Rochester Gas and Electric Corporation for Electric Service – Compliance Tariff Filing

Dear Secretary Brillling:

The enclosed tariff leaves, issued by Rochester Gas & Electric Corporation (“RG&E”) are filed in compliance with the New York State Public Service Commission’s (“Commission”) Order Modifying Fixed Price Offer, issued and effective August 28, 2008, in Case 03-E-0765 (“the August 2008 Order”). These tariff leaves are transmitted for filing in compliance as identified herein and in accordance with the requirements of Appendix 7-H (electronic tariff filing system) to the Commission’s Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

In compliance with the Ordering Clause 1 of the August 2008 Order, today’s filing sets forth the tariff revisions necessary to effectuate the required changes to the Fixed Price Offer to become effective October 1, 2008. A listing of the proposed revised tariff leaves is enclosed as Attachment A. RG&E will also be submitting an additional compliance filing which shall set forth the rates to become effective January 1, 2009.

Revisions reflected in the proposed tariffs to the Company’s Fixed Price Offer as adopted by the August 2008 Order include: all customers subject to the Transition Charge will pay a fixed Transition Charge with annual reconciliation; addition of the specific calendar reference when RG&E shall collect the forward wholesale prices used to determine the Fixed Price Offer and fixed Transition Charge; a change to the Open Enrollment Period start date and duration; elimination of an April 1<sup>st</sup> adjustment to the fixed price; and a change in the retail conversion factor used to calculate the fixed price.

The Company respectfully requests a waiver of the newspaper publication requirement pursuant to Ordering Clause 5. All customers will be made aware of the 2009 fixed prices and changes through various means, including enrollment materials (which contain the price information) mailed to all eligible customers; the Company’s voice response system and website (which contain the price information); and general Outreach and Education associated with the “Voice Your Choice” program.
