Dear Secretary Brillling:

Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 54 applicable to Service Classification Nos. 1, 2, and 3, and Delivery Adjustment Charge Statement No. 50 applicable to Service Classification Nos. 1, 2, 3, 5, 7, 8, and 9 of our Rate Schedule P.S.C. No. 8 – Gas. The Monthly Gas Supply Charge Statement No. 54 and the Delivery Adjustment Charge Statement No. 50 will be effective commencing with gas used on or after June 1, 2006.

The estimated amount related to surcharges and credits included in Statements No. 50 & 54 is \$880,000 based on estimated June 2006 sales of 16,600,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is a decrease of \$464,300 on a monthly basis.

The surcharge calculation for June 2006 Intermediate Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.2 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.02140 /Mcf is applicable for June 1, 2006 through June 30, 2006.

The surcharge calculation for June 2006 Upstream Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.1 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.03270 /Mcf is applicable for June 1, 2006 through June 30, 2006.

In addition, Deficiency Imbalance Sales Service Rate Statement No. 104, Demand Transfer Recovery Rate Statement No.101, Gas Transportation Statement No.101, Natural Gas Vehicle Statement No. 104, Standby Sales Service Rate Statement No.104, Transportation Sales Service Rate Statement No.106, Reserve Capacity Cost Statement No. 67, Weather Normalization Clause Multipliers Statement No. 50, Distributed Generation Statement No. 33, LIRA Minimum Charge Statement No.11, Minimum Bill Credit Statement No.11, Merchant Function Charge Statement No.14, Incremental Monthly Gas Supply Charge Statement No. 10 and Low Income Customer Affordability Assistance Program No. 2 are included.

This statement is filed in compliance with 16 NYCRR, Section 270.55. Information pertaining to section 270.55d(7) will be delivered under separate cover letter.

In connection with this filing, the Company is also required to submit information that contains trade secrets. Accordingly, the Company has filed the required information with the Department Records Access Officer, together with a request for trade secret protection under the Commission's regulation. The instant filing includes redacted copies of the documents submitted to the Department Records Access Officer. The information for which trade secret protection has been requested is deleted. Copies of the same documents, with the redacted sections shaded (but legible) for identification, are being submitted to the Department Records Access Office under separate cover.
