Reasons for Proposed Revisions

This filing is being submitted to make "housekeeping" revisions to NYSEG's gas tariffs.

Overview of the Filing

The purpose of this filing is to consolidate tariff changes made in separate filings described herein. The Company filed revisions in compliance with the Commission's <u>Order Denying Tariff Amendments</u>, issued and effective December 22, 2006 ("December Order"), and tariff revisions in compliance with the Commission's <u>Order on Capacity Release Programs</u> issued on August 30, 2007 in Case No. 07-G-0299 ("Capacity Order"). The Company also filed tariff changes to establish an Incremental Gas Supply Charge for daily metered transportation customers requesting supply service from the company that were approved by the Commission on October 17, 2007 ("IGSC Order"). Due to the timing of these filings and their effective dates, tariff revisions for the filings in compliance with the Capacity Order and approved in the IGSC Order did not contain Bill Issuance Charge filed in compliance with the December Order.

Since the December Order, NYSEG filed revisions to PSC No. 87 to implement an Incremental Gas Supply Charge applicable to daily metered transportation customers requesting supply service from the company and revisions to PSC No. 88 in compliance with the Capacity Order.

The proposed revisions herein reflect the consolidation of these filings to ensure that the Bill Issuance Charge that was filed in compliance with the December Order becomes effective on April 1, 2008, as well as the changes that were filed and approved in the filings identified above.

Newspaper Publication

NYSEG requests waiver of publication of these proposed changes in accordance with Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1, as these "housekeeping" revisions have no direct impact on NYSEG's gas customers.
