Purpose and Details of the Filing

Based on discussions with the Department of Public Service Staff ("Staff"), the Company is filing further revisions to tariff leaves that were filed on October 30, 2007 to become effective on February 26, 2008. Tariff leaves No. 17 and No. 73 were modified to update the name of the Office of Electric, Gas and Water of the New York Public Service Commission. Leaf 17.1 was revised to include language PSC staff requested be added from Appendix B of the Commission Order. Leaf 17.1.1 was revised to modify the market price for diverted gas. Additionally, Leaf 90.1 was modified to include language that the Company will recover compensation for diverted gas through the Monthly Gas Supply Charge.
