The enclosed tariff leaves, issued by Niagara Mohawk Power Corporation, d/b/a National Grid (hereinafter "the Company") are transmitted for filing in compliance with the Commission's August 23, 2007 Order in Case 06-G-0059 and the requirements of the Public Service Commission of the State of New York ("Commission").

On October 24, 2007 the Company filed revised tariff leaves in compliance with the Commission's August 23, 2007 Order Adopting Gas Curtailment Guidelines and Requirements to take effect on a temporary basis. The Company's October 24, 2007 filing incorporated revisions to Rule 3 – Priority of Service as set forth in the Gas Curtailment Guidelines set forth in Appendix B to the August 23, 2007 Order.

The enclosed revised tariff leaves are submitted pursuant to further discussions with Staff regarding minor tariff language revisions to tariff leaf 36, Rules 3.6 and 3.6.1 and tariff leaf 37.1, Rule 3.7.2.

Specifically, Rule 3.6 has been revised to supplement language that the Company will recover compensation costs from customers through the Monthly Cost of Gas to include "or an equivalent mechanism, subject to commission review".

Rule 3.6.1 has been supplemented to clarify that the compensation for diverted gas will be at the stated price components "in effect at the time of curtailment" and deletes reference to any upstream pipeline penalties incurred. Additionally, Rule 3.6.1 has been revised to replace the

language "with adequate support as determined in the sole and absolute discretion of the Company" with "to the Company's satisfaction".

Finally, Rule 3.7.2 is revised to reflect the Office of Electric, Gas and Water of the New York Public Service Commission.

Copies of this tariff filing have been served on all parties to Case 06-G-0059.

In accordance with Ordering paragraph 4 of the August 23, 2007 Order, newspaper publication of the proposed tariff changes required by 16 NYCRR 720-8.1 are waived.
