Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 68 applicable to Service Classification Nos. 1, 2, and 3, and Delivery Adjustment Charge Statement No. 64 applicable to Service Classification Nos. 1, 2, 3, 5, 7, 8, and 9 of our Rate Schedule P.S.C. No. 8 – Gas. The Monthly Gas Supply Charge Statement No. 68 and the Delivery Adjustment Charge Statement No. 64 will be effective commencing with gas used on or after August 1, 2007.

The estimated amount related to surcharges and credits included in Statements No. 64 & 68 is \$301,000 based on estimated August 2007 sales of 9,810,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is a decrease of \$1,003,400 on a monthly basis.

The surcharge calculation for August 2007 Intermediate Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.2 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.02340 /Mcf is applicable for August 1, 2007 through August 31, 2007.

The surcharge calculation for August 2007 Upstream Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.1 of P.S.C. No 8- Gas results in a unit surcharge of \$0.01380 /Mcf is applicable for August 1, 2007 through August 31, 2007.

In addition, Deficiency Imbalance Sales Service Rate Statement No. 118, Demand Transfer Recovery Rate Statement No.115, Gas Transportation Statement No.115, Natural Gas Vehicle Statement No. 118, Standby Sales Service Rate Statement No.118, Transportation Sales Service Rate Statement No.120, Reserve Capacity Cost Statement No. 81, Weather Normalization Clause Multipliers Statement No. 64, Distributed Generation Statement No. 47, LIRA Minimum Charge Statement No.25, Minimum Bill Credit Statement No.25, Merchant Function Charge Statement No.28, Incremental Monthly Gas Supply Charge Statement No. 24 and Low Income Customer Affordability Assistance Program Statement No. 16 are included.
