Dear Secretary Brilling:

Consolidated Edison Company of New York, Inc. ("the Company") is filing today with the Public Service Commission ("the Commission") amendments to its Schedule for Gas Service, PSC No. 9 – Gas ("Gas Tariff") in compliance with the Commission's Order Adopting Residential Distributed Generation Rates and Directing Further Tariff Amendments ("the Order"), issued and effective September 6, 2005, in the above referenced proceeding.

The specific leaves being revised are identified in Appendix A and are being filed on not less than one day's notice to become effective October 4, 2005, on a temporary basis, in accordance with Ordering Clause 2 of the Order.

Summary of Tariff Changes

On November 2, 2004 and July 5, 2005, the Company filed tariff amendments implementing a new Service Classification Rider to its Gas Tariff, designated as Rider J – Residential Distributed Generation Rate, in compliance with the Commission's Order issued and effective August 4, 2004 in the above referenced proceeding. Today's filing amends the tariffs filed in November 2004 and July 2005 to conform with the September 6, 2005 Order with respect to the following:

- The eligibility requirement that Service Classification ("SC") 1 non-heating and SC 3 heating Customers in buildings with one to four residential dwelling units maintain a minimum Annual Load Factor and all associated references have been eliminated.
- The prohibition against Distributed Generation unit(s) determined to be either an emergency electric generator or a standby generation unit as an eligibility requirement for the Residential DG rates has been eliminated.

• Except as noted above, all other tariff provisions proposed in the November 2, 2004 filing and amended in the July 5, 2005 filing have not been changed.

Notices

In accordance with Ordering Clause 3 of the September 6th Order, the Company hereby requests waiver of newspaper publication of the tariff revisions filed herein.
