Dear Secretary Brilling:

Orange and Rockland Utilities, Inc. ("O&R" or "the Company") hereby submits for filing the following tariff leaves proposing revisions to its Schedule for Gas Service, P.S.C. No. 4 – Gas ("Gas tariff").

This filing is made in compliance with Ordering Clause 5 of the Commission's "Order Adopting the Terms of a Joint Proposal¹ and Clarifying a Provision" issued October 23, 2003, in the above-referenced proceeding ("Order"). The tariff leaves being filed are effective November 1, 2005.

The purpose of this filing is to implement for "Rate Year 3" (i.e., November 1, 2005 through October 31, 2006) the rate design changes set forth in Appendix F of the Joint Proposal.

Summary of the Proposed Changes

In compliance with the Order, the Company is filing the following changes to its Gas tariff:

- The first block charge (first 3 ccf or less) for Service Classification ("SC") No. 1, SC No. 2, and SC No. 6 - Rate Schedule I has been increased to \$11.00 from \$9.37. The first block charge of SC 6 Rate Schedule II has been increased to \$144.11 from \$135.10.

- The remaining incremental revenue requirement has been recovered from all rate block charges of SC No. 1, SC No. 2, and SC No. 6 after the first block charge.
- The "Factor of Adjustment" used in the calculation of the "Gas Supply Charge" set forth in General Information Section 12.1 has been changed to 1.019 from 1.025. The calculation of the updated Factor of Adjustment is set forth in Appendix A to this filing letter.
