Leafs 69 and 70 have changes to the title of H. PSC No. 17 Leaf No. 2 has changes to page numbering. P.S.C. No. 19 Leaf No. 3 has changes to page numbering. P.S.C. Leaf Nos. 27, 28, 29 changed the letter title from E. to F. Leaf Nos. 77, 174, 175, 178, 178.1, 204.1, 207, 211, and 212 and P.S.C. No. 20, Leaf Nos. 34, 169, 172, and 173 remove references to "shoulder" peak hours, P.S.C. No. 19 Leaf 196 changes the wording to calculate loss factor. P.S.C. No. 20, Leaf 179 has added information for Pole Attachment Charges.

Also included is Special Services Statement No. 2 which included incorrect titles for some charges and some incorrect rates.
