RG&E is filing revisions to its tariffs P.S.C. No. 19 – Electricity, Schedule for Electric Service and P.S.C. No. 20 – Electricity, Schedule for Electric Distribution Service, which are the current designations, and not to tariffs P.S.C. No. 14 – Electricity and P.S.C. No.15 – Electricity as listed Appendix B to the August Order, which are the previous designations.

RG&E has incorporated verbatim into its tariff PSC 19 Leaf Nos.128 and 147 and its tariff PSC 20 Leaf Nos.131 and 150 the revised Standard Interconnection Requirements (“SIRs”) set forth in Appendix A to the August Order.

RG&E has modified its tariff PSC 19 Leaf Nos.163.1, 165.1, and 178.1 and its tariff PSC 20 Leaf Nos.167.1, 167.2, and 169 to eliminate the customer charge offset for non-demand customers.

Upon discussions with Commission staff, RG&E concludes that it is not “precluding the installation of two interval meters” as stated at page 12 of the August Order, and RG&E’s existing tariffs are in compliance with the August Order. Therefore, no tariff modifications are filed pursuant to this issue.

Also, RG&E is making one housekeeping change, to its PSC 20 tariff Leaf No.168, Paragraph 7.a., revising the reference from “Rule 14” to “Rule 10”.

In accordance with Ordering Clause No. 4 of the August Order, newspaper publication of the proposed tariff amendments has been waived.
