In compliance with Ordering Clause No. 2, NYSEG has modified the above stated tariff leaves to reflect the revised Standardized Interconnection Requirements, including the standard applications and contracts. Specifically, NYSEG has removed the contents

of the previous Standard Interconnection Requirements from tariff leaves 108 through 149 of PSC 119 and created Addendum-SIR within PSC 119 to reflect, verbatim, the appendix to the Order.

In further compliance with Ordering Clause No. 3, NYSEG has modified its PSC 119, Section 9 – General Information overview of Distributed Generation Interconnection Requirements to refer to the revised interconnection requirements within Addendum-SIR and to the revised title of the standardized interconnection contract. Similarly, tariff leaves within PSC 120 – Electricity have been revised to refer to the revised interconnection requirements within Addendum-SIR and to the revised title of the standardized interconnection contract. On Leaf 107 of PSC 119, NYSEG has clarified that no charge for engineering reviews is assessed for units of 15 kVA and less.

According to Ordering Clause No. 2, the requirement of Section 66(12) of the Public Service Law as to newspaper publication of the proposed tariff amendments has been waived.
