Dear Secretary Brilling:

The enclosed tariff leaves, issued by Rochester Gas and Electric Corporation ("RG&E" or the "Company"), are transmitted for filing in compliance with the New York State Public Service Commission's ("Commission") Order Modifying Standardized Interconnection Requirements ("November 17 SIR Order"), issued and effective November 17, 2004 in the above referenced proceeding. This filing is also made in accordance with Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H). The leaves are issued December 23, 2004, to become effective December 31, 2004. See Appendix 1 for an Index of leaves.

In accordance with Ordering Clause No. 2, RG&E is incorporating verbatim into its tariff P.S.C. No. 19 – Electricity, Schedule for Electric Service, the revised Standardized Interconnection Requirements ("SIR"), including the standard applications and contracts, set forth in the appendix to the November 17 SIR Order, as the SIR Addendum. The existing Rule 10 is being replaced by a brief SIR applicability and requirements description. Numerous references are being changed from "Rule 10" to "the SIR Addendum".

Housekeeping changes are being made to S.C. No. 1 – Residential Service and S.C. No. 4 – Residential Service – Time of Use Rate. These changes update the language to accurately represent the current operational practice of RG&E, including renaming the Special Provision from "Residential Photovoltaic Service" to "Residential Solar Electric Service Option" and requiring the customer to execute a New York State Standardized Contract for Interconnection.
