The Company makes this filing in compliance with the Commission's: (i) Order Adopting Provisions of the Joint Proposal with Modifications, issued February 27, 2002 in Cases 01-E-0359 et al. (the "JP Order"); (ii) the Order Directing Rate Design and Revenue Allocation, issued November 22, 2002 in Case 01-E-0359 (the "Rate Order"); and (iii) Untitled Order approving delivery rate design, issued August 25, 2004 in Case 01-E-0359. The enclosed tariff modifications also are filed pursuant to the Commission's: (i) Order Adopting Economic Development Plan In Part And Providing For Further Proceedings, issued October 9, 2002 in Cases 01-E-0359 et al.; and (ii) the Order Modifying Economic Development Plan and Tariffs and Denying Rehearing, issued May 9, 2003 in Cases Nos. 01-E-0359 et al. (collectively, the "Economic Development Orders").

NYSEG makes this filing to set forth the Bundled Rate Option ("BRO" or "NYSEG Fixed Price") rates that become effective January 1, 2005, as provided for in NYSEG's Electric Joint Proposal approved in the JP Order. In accordance with the Rate Order, the Company filed revised revenue neutral delivery rates, on June 17, 2004, for Service Classification Nos. 1 and 2. The Commission approved those delivery rates in the Untitled Order and the enclosed tariff leaves containing the NYSEG Fixed Price rates for Service Classification Nos. 1 and 2 reflect those approved delivery rates. This filing also includes forecasted commodity rates and fixed non-bypassable wires charges ("transition charges") as provided for in the Electric Joint Proposal approved in the JP Order and the Economic Development Orders.

This filing also sets forth the NYSEG Fixed Price rates for all other Service Classifications. Delivery rates for customers served under such classifications will not

change on January 1, 2005. For such customers, the proposed Fixed Price rates reflect the delivery rates that became effective January 1, 2003, as well as forecasted commodity rates and transition charges as provided for in the Joint Proposal and the Economic Development Orders.

## Publication and SAPA

The Company requests that the requirement of § 66(12)(b) of the Public Service Law and 16 NYCRR §720-8.1 as to newspaper publication be waived. Customers will receive Enrollment Kits from the Company that include the rates filed herein. The information in the Enrollment Kits assists customers in making informed decisions regarding their rate option choice. The proposed prices also are available to customers at NYSEG's website and by calling NYSEG's Voice Response Unit.

A State Administrative Procedures Act Notice is enclosed for publication in the State Bulletin.
