Rochester Gas and Electric Corporation ("RG&E") hereby submits for filing the following enclosed tariff leaves in compliance with the New York Public Service Commission's ("Commission's") Order Modifying Suspension Fees And Other Tariff Provisions And Granting Further Relief, issued October 25, 2004 in Case 03-M-0117 (the "Order"). This filing is also made in accordance with Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

PSC No. 16 – Gas
Leaf No. 110.3, Revision 3

PSC No. 19 – Electricity
Leaf No. 102.2, Revision 4

Effective: November 24, 2004

In compliance with Ordering Clause No. 1 of the Order, RG&E has modified the above stated tariff leaves to update previously filed suspension fees with newly calculated suspension fees. The updated fees were calculated by applying the applicable GDP inflation factor to the currently effective electric and gas reconnection fees that had last been updated in 2000. Work papers detailing the inflation factors are attached to this filing.

Pursuant to Ordering Clause No. 3 of the Order, the above leaves have also been modified to remove language referring to "attempted" suspensions. ESCOs will be charged only for completed suspensions. It should be noted that no suspension requests have been received, therefore no fees for attempted or completed suspensions have been charged to ESCOs, and no refunds are required.

Pursuant to Ordering Clause No. 4, where a residential customer's delivery service is contemporaneously shut off as a suspension for the ESCO and as a disconnection for RG&E, because the customer is in arrears to both, the suspension fee charged the ESCO will be reduced by 50%.

These tariff leaves will be in effect from November 24, 2004 to December 31, 2004. Beginning January 1, 2005, tariff leaves that were filed October 6, 2004, in compliance the Joint Proposal on Purchase of Accounts Receivable filed with the Commission and dated August 20, 2004, become effective.

According to Ordering Clause No. 6 of the Order, the requirement of Section 66(12)(b) of the Public Service Law as to newspaper publication of the proposed tariff amendments has been waived.
