Dear Secretary Brilling:

Orange and Rockland Utilities, Inc. ("O&R" or the "Company") hereby submits for filing revised tariff leaves reflecting revisions to its Schedule for Gas Service, P.S.C. No. 4 – GAS (the "Gas tariff").

The tariff leaves filed electronically today are to become effective on November 1, 2004. Appendix A to this letter sets forth the tariff leaves being filed.

Reason for Proposed Tariff Modifications

On August 10, 2004, the Company filed with the Commission changes to its Gas tariff to include a new supplementary application form for service to customers with gas-fired distributed generation facilities applying for Rider B. The tariff leaves filed by the Company on August 10, 2004 bear an effective date of November 1, 2004.

Rider B, which was approved by the Commission effective January 1, 2004, provides that customers submit a form, provided by the Company and completed and signed by a professional engineer, that includes information necessary for the Company to determine a customer's initial eligibility for service and other information required for billing purposes.

The purpose of the Company's August 10, 2004 filing was to include the form in its Gas tariff and to provide for a reference to it in Rider B. Subsequent to the Company's August 10, 2004 filing, the Staff of the Commission requested that the Company include the form in its Gas Transportation Operating Procedures ("GTOP") in lieu of including it in the Gas tariff. The purpose of this filing is to make changes to the Gas tariff that are necessary to reflect inclusion of the form in the Company's GTOP and not in the Gas tariff.

Under separate cover, the Company will file shortly its GTOP to reflect the new supplementary application form applicable to Rider B.
