Dear Secretary Brilling:

In accordance with the Joint Proposal on Electric and Natural Gas Economic Development Incentive Programs ("Economic Development JP"), dated October 4, 2004 in the above referenced proceedings, Rochester Gas and Electric Corporation ("RG&E" or the "Company") hereby submits tariff leaves as listed below. This tariff filing reflects revisions to RG&E's Empire Zone programs and the addition of a new Incremental Load Rate (ILR) program as set forth in the Economic Development JP. These services are offered to both electric and gas non-residential customers served under RG&E's P.S.C. No. 19 – Electricity - Schedule for Electric Service and P.S.C. No. 16 – Gas - Schedule for Gas Service. This tariff submittal also includes a method for transitioning existing Incremental Manufacturing Load Rider (IMLR) customers to the new ILR service.

RG&E is requesting approval of these revised and original leaves to the Company's Schedule for Gas Service, P.S.C. No. 16 – Gas and the revised and original leaves to the Company's Schedule for Electric Service, P.S.C. No. 19 – Electricity. The leaves are issued October 5, 2004 to become effective January 1, 2005.
