Dear Secretary Brilling:

Rochester Gas and Electric Corporation ("RG&E" or the "Company") issues the enclosed tariff leaves as revisions to the filing that became effective May 28, 2004 in compliance with the New York State Public Service Commission's ("Commission") May 20, 2004 Order Adopting Provisions of Joint Proposals With Conditions in the above-referenced proceedings. The leaves are issued June 7, 2004, to be effective June 8, 2004. See Appendix 1 for an Index of leaves.

The submittal of these revised tariffs are necessary because of the PSC's June 2, 2004 Economic Development order in cases 02-E-0198 and 02-G-0199 which requires that rates for EDZ and IMLR customers remain unchanged until new unbundled tariffs are implemented in January of 2005. In addition, PSC 19 - Electricity, Service Classification ("SC") No. 8 - RTP needs to be revised. This revision is necessary to reflect a reduction in demand and delivery rates to offset the approved increase in the monthly customer charge. We have discussed these changes with Commission staff.
