Dear Secretary Brilling:

Orange and Rockland Utilities, Inc. ("O&R" or the "Company") hereby submits for filing tariff leaves reflecting "housekeeping" changes to its Schedule for Gas Service, P.S.C. No. 4 – GAS (the "Gas tariff").

The tariff leaves filed electronically today are effective on April 1, 2004. Appendix A to this filing letter sets forth the tariff leaves being filed.

#### Reason for the Filing

On December 11, 2003, the Company filed changes to its Gas tariff to implement a new Winter Bundled Sales ("WBS") Service for customers and Marketers participating in the Company's Gas Transportation Service Program<sup>1</sup>. The tariff leaves filed on December 11, 2003 reflected an April 1, 2004 effective date. On February 18, 2004, the Company filed changes to its Gas tariff, including tariff changes to some of the same tariff leaves filed on December 11, 2003, in compliance with the Commission's orders in Case Nos. 98-M-1343, 99-M-0631, and 03-M-0017 dealing with retail access business rules, customer billing arrangements, and implementation of Chapter 686 of the Laws of 2002. The tariff leaves filed on February 18, 2004 became effective on February 19, 2004.

By this filing, the Company proposes "housekeeping" changes to its Gas tariff to reflect on the tariff leaves filed today (1) the tariff changes that became effective on February 19, 2004 and (2) the tariff changes associated with the WBS Service that were filed on December 11, 2003 and February 26, 2004 and that are effective April 1, 2004 in accordance with the Commission's order issued March 19, 2004 (the "Order") in the above referenced cases.

<sup>1</sup> On February 26, 2004, the Company filed further tariff revisions to Leaf No. 158 following discussions with Staff regarding the Company's December 11, 2003 WBS filing. The Company added language providing more detail with respect to the determination of the rate to be charged Marketers for the gas they purchase from the Company under the WBS program. The tariff revisions to Leaf No. 158 filed on February 26, 2004 bear an effective date of April 1, 2004.
