The enclosed leaves, issued by New York State Electric & Gas Corporation ("NYSEG" or "the Company") are transmitted for filing in compliance with the requirements of the New York State Public Service Commission ("PSC" or "Commission").

PSC No. 87 – Gas, Schedule for Gas Service

Leaf No. 37, Revision 2 Leaf No. 37.1, Original

PSC No. 88 – Gas, Schedule for Gas Service - Transportation

Leaf No. 13, Revision 8 Leaf No. 93, Revision 2

Leaf No. 94, Revision 2

This filing is made in further compliance with the Company's August 8, 2003 Phase 2A Joint Proposal (the "Phase 2A-JP"), as approved by the PSC in its <u>Order Establishing Terms and Conditions of Service</u>, Case 01-G-1668, issued September 23, 2003 (the "Order"). Pursuant to the Order, these tariff changes are to be filed on not less than one day's notice prior to the effective date.

The following proposed tariff revisions to the Company's PSC Nos. 87 and 88 – Gas tariffs are being made in further compliance with the Phase 2A-JP and the Order:

1) PSC No. 87 – Service Classification No. 6, Standby Sales Service, (Leaf No. 37) is being revised to reflect the appropriate reference to the cash-out methodology which became effective January 1, 2004, as set forth in the Company's Phase 2A-JP. The Company no longer defines a "Maximum Daily Gas Index" in the PSC No-88 Gas tariff; therefore, this

reference is being eliminated and replaced with the appropriate daily price index descriptions used in calculating the Standby Commodity Charge.

- 2) PSC No. 88 General Information Section 5, Non-Daily Metered Transportation Requirements, (Leaf No. 13) is being revised to reflect a minor clarification regarding the forecasted Daily Aggregation Volume (DAV) provided to Aggregation Pool Operators. The previous tariff leaf indicated that a four-day forecast is provided; it is actually a six-day forecast.
- 3) PSC No. 88 Service Classification No. 12, Repackaged Gas Service, (Leaf Nos. 93 and 94) is being cancelled, as set forth in Section XXIV of the Phase 2A-JP. All existing SC 12 agreements have expired, and the Company has not offered this service to any new customers after September 12, 2002 (the date of the Phase 2A-JP), as stated in the Phase 2A-JP as well as the SC 12 tariff.

Pursuant to Ordering Clause No. 2 of the Order, the requirement of Section 66(12) (b) of Public Service Law as to newspaper publication is waived.

A copy of this filing has been served upon all parties to this proceeding, in accordance with Ordering Clause No. 2 of the Order.
