RG&E is hereby filing the following tariff revisions to become effective July 1, 2010, in compliance with the requirements of the New York State Public Service Commission ("PSC" or "Commission"):

<u>PSC No. 19 – Electricity, Schedule for Electric Service</u> Leaf No. 58, Revision 8, Superseding Revision 7

This filing is also made in accordance with Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

Leaf No. 58 is revised to update the URD applicant contributions and credit. Also enclosed is the report for the proposed rates required by 16 NYCRR 98.6.

The Company requests that the requirement of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 as to newspaper publication be waived because these tariff changes have minimal impact on the majority of RG&E's customers.
