Dear Secretary Brillig:

Orange and Rockland Utilities, Inc. (the "Company") hereby transmits for electronic filing today with the Public Service Commission (the "Commission") an addendum, Addendum-UBP-6, to its Schedule for Gas Service, P.S.C. No. 4 – Gas.

Addendum-UBP-6 incorporates verbatim the revised "Uniform Business Practices" ("UBP"), dated September 2009, which was approved by the Commission in its Order Granting Petition, issued and effective September 22, 2009. Pursuant to that Order, Section 5.D.6 of the UBP was revised.

Note that Addendum UBP-5 had two parts: Part A, applicable to contracts entered into before November 1, 2008, incorporated verbatim the text of Addendum-UBP-4; and Part B, applicable to contracts and contract renewals made on or after November 1, 2008, incorporated verbatim the UBP text approved by the Commission's Order Adopting Amendments to the Uniform Business Practices, Granting in Part Petition on Behalf of Customers and Rejecting National Fuel Gas Distribution Corporation's Tariff Filing, issued and effective October 27, 2008, in Cases 98-M-1343, 07-M-1514, and 08-G-0078.

Following consultation with Department of Public Service Staff, Part A to Addendum-UBP has been eliminated,¹ and Addendum-UBP-6 contains solely the text approved by the Commission's Order on September 22, 2009.

¹ The Company was concerned, on one hand, about removing UBP text applicable to contracts entered into prior to November 1, 2008, and, on the other hand, having to maintain multiple versions of the UBP (i.e., to reflect UBP changes applicable to pre-November 2008 contracts, UBP changes applicable to contracts dated November 1, 2008 and thereafter, and UBP changes applicable regardless of contract date). Staff indicated that only the current UBP version must be retained as an addendum to the utility's tariff, since the earlier versions remain on the Commission's website.
