Dear Secretary Brillling:

Consolidated Edison Company of New York, Inc. ("Con Edison or the Company") hereby submits for filing with the New York State Public Service Commission (the "Commission") revisions to its Schedule for Gas Service, PSC No. 9 Gas (the "Gas Tariff").

The tariff leaves reflecting the revisions are identified below:

The leaves have an issue date of March 1, 2010, and an effective date of April 1, 2010

Reason for the Proposed Filing

On November 30, 2009, pursuant to the Commission's Order Approving Certain Commercial and Industrial Customer Energy Efficiency Programs with Modifications, issued and effective October 23, 2009, in Case 07-M-0548 and Case 09-G-0363 ("October 2009 Order") the Company filed tariff revisions, effective January 1, 2010, to provide for additional EEPs funding through the System Benefits Charge ("SBC") for the period January 1, 2010 to December 31, 2013. The October 2009 Order provided for additional EEPs collections of \$4,730,669 in 2010; \$7,656,907 in 2011; \$627,117 in 2012; and \$91,550 in 2013. Subsequent to the October 2009 Order, the Commission issued two additional orders in the subject cases: Order Approving Certain Commercial and Industrial Customer Energy Efficiency Programs with Modifications and Addressing Independent Program Administrator Filings, issued and effective November 13, 2009 ("November 2009 Order"), and Order Approving Certain Commercial and Industrial; Residential; and Low Income Residential Customer Energy Efficiency Programs With Modifications, issued and effective January 4, 2010 ("January 2010 Order"). Both of these Orders allow the Company to collect additional EEPs

amounts through the SBC. The November 2009 Order provides for additional SBC collections of \$1,305,681 during the period April 1, 2010 through December 31, 2010, and \$1,740,907 for the year 2011. The January 2010 Order further provides for additional SBC collections of \$13,878,432 during the period April 1, 2010 through December 31, 2010; \$14,599,607 for the year 2011; \$279,121 for the year 2012; \$317,876 for the year 2013; and \$141,861 for the year 2014. Thus total additional EEPs annual collections during the period January 1, 2010 through December 31, 2014 resulting from the October 2009, November 2009, and January 2010 Orders are as follows: \$19,914,782 in 2010; \$23,997,421 in 2011; \$906,238 in 2012; \$409,426 in 2013 and \$141,861 in 2014.

Summary of Proposed Changes

In compliance with the November 2009 and January 2010 Orders, Leaf Nos.182 and 183, Section IX.16, have been amended to include provisions to collect additional amounts through the SBC. In addition, a revised Statement of System Benefits Charge applicable to firm sales and firm transportation customers will be issued on March 1, 2010, to be effective April 1, 2010, after reconciliation of the SBC collection vs. target for the period January 1, 2010 to March 31, 2010 (including estimates for February and March).

Conclusion

Pursuant to Ordering Clause 9 of the November 2009 Order and Ordering Clause 12 of the January 2010 Order, the Company is filing its tariff amendments and statement on not less than 30 days' notice to become effective on April 1, 2010. Furthermore, pursuant to Ordering Clause 9 of the November 2009 Order and Ordering Clause 12 of the January 2010 Order, the requirements of Section 66(12)(b) of the Public Service Law as to newspaper publication of the changes proposed by the tariff amendments have been waived.
