Orange and Rockland Utilities, Inc. (the "Company") hereby submits for filing 7th Revised Leaf No. 112 reflecting revisions to its Schedule for Gas Service, P.S.C. No. 4 – Gas ("Gas Tariff").

This leaf is issued March 2, 2010, to become effective April 1, 2010.

Also enclosed for filing is the Company's Statement of System Benefits Charge, Statement No. SBC – 5 to its Gas Tariff. This Statement is issued March 2, 2010, to become effective April 1, 2010.

Reason for Filing

In its Order Approving Certain Commercial and Industrial; Residential; and Low-Income Residential Customer Energy Efficiency Programs with Modifications (the "Order"), issued and effective January 4, 2010, in the above-referenced cases, the Commission approved changes in the annual amounts to be collected through the Company's System Benefits Charge ("SBC"). The Order directed the Company to collect the following incremental gas SBC amounts: \$528,294, \$1,130,878, \$30,509, \$34,745 and \$15,506, in 2010, 2011, 2012, 2013, and 2014, respectively.

Summary of Proposed Changes

General Information Section 23 of the Gas Tariff has been revised to reflect the changes in SBC collections as directed by the Order. Any over- or under-collections (differences in SBC collections from the target amount) for each calendar year through

2013 will be reconciled and reflected in the subsequent year's SBC. Any over- or under-collections of the SBC during 2014 will also be reconciled and credited to or collected from customers as directed by the Commission.

Conclusion and Notice

In compliance with the Order, the Company is filing its tariff amendment and Statement on not less than 30 days' notice to become effective on April 1, 2010. The requirements of Section 66(12)(b) of the Public Service Law as to newspaper publication were waived in ordering clause 12 of the Order.
