Statement of Gas and Pipeline Costs and Adjustments No. 135 which sets forth the gas cost adjustments applicable to monthly usage under Service Classification Nos. 1A, 1AR, 1B, 1BR, 1BI, 1B-DG, 2-1, 2-2, 3, 4A, 4A-CNG, 4B, 7, 14 and 21 of PSC No. 12-GAS.

Statement of Transportation Adjustment Charges No. 3 which sets forth the transportation cost adjustments applicable to monthly usage under Service Classification Nos. 17-1A, SC17-1AR, SC17-1B, SC17-1BR, SC17-2-1, 17-2-2, SC17-3, SC17-4A, SC17-4A-CNG, SC17-4B, SC17-7, SC17-14 and SC17-21 of PSC No. 12-GAS.

In addition, the following tiered floor prices will take effect on **November 01, 2009** unless otherwise revised by a supplemental filing to account for major changes in gas prices and supplies, as follows:

\$5.7407/dth for sales to Service Classification Nos. 5A. \$5.6271/dth for sales to Service Classification Nos. 6C, 6G, and 6M.

The first tier price of \$5.7407/dth represents the Company's incremental cost of gas to serve S.C. No. 5A plus an allowance for unaccounted for gas.

The second tier price of \$5.6271/dth represents the Company's firm weighted average cost of gas to serve S.C. No. 6C, 6G and 6M customers plus an allowance for lost-and unaccounted-for-gas and an allocated demand charge.
