Enclosed for filing with the Commission are tariff amendments of Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") in compliance with recent modifications to New York State Public Service Law (PSL), Section 66-j.

Purpose of the Filing

On September 23, 2009, the Company received a notice from Mr. Bruce E. Alch, Chief, Electric Rates and Tariffs, Office of Electric, Gas and Water of the New York State Department of Public Service directing utilities to file tariff amendments necessary to conform to recent amendments to PSL, Section 66-j which became effective on August 26, 2009. These amendments revised this law and the public authorities law in relation to the net energy metering for micro-combined heat and power generating systems.

The above leaves comply with this directive with the revisions set forth below.

- 1. Leaf No. 2 Table of Contents to add Micro-Combined Heat and Power and Fuel Cell Electric Generating Equipment.
- 2. Leaf No. 37 Rule No. 1 Definitions and Abbreviations, specifically Rule Nos. 1.92 has been revised and Rule Nos. 1.93 and 1.94 have been added to define Micro-Combined Heat and Power and Fuel Cell Electric Generating Equipment.

- 3. Leaf Numbers 197-199.1 Rule No. 36 Net Metering for Solar and Farm Waste Electric Generating Systems has been revised to add the language for Micro-Combined Heat and Power and Fuel Cell Electric Generating Equipment per the requirements and directives of the revised law.
- 4. Leaf No. 418 Exemptions from SC No. 7 Standby Service has been revised to include Micro-Combined Heat and Power and Fuel Cell Electric Generating Equipment and refer back to each exemptions respective rules.

Per this notice from Mr. Alch, these leaves are to be filed by November 27, 2009 with an effective date of February 26, 2010. Redlined leaves showing these amendments will be provided upon request.
