To P.S.C. No. 214 Electricity

Effective: November 16, 2009

Purpose of Filing

On August 20, 2009, a filing was submitted to the PSC proposing to make minor conforming modifications to the current PSC No. 214 Electricity Street Lighting tariff. These modifications proposed a consistent format for all information and pricing within each service classification of PSC No. 214. The Company believes that this consistent format will provide customers, as well as Company personnel, a more uniform presentation of the existing information contained in each service classification.

The above leaves, which were contained in the original filing, have been further revised for revisions that were either unintentionally omitted or in need of further amendments. Redlined leaves showing these further revisions will be provided upon Staff request.

As stated in the filing of August 20, 2009, these proposed changes have no impact on the products, services and business applications currently in practice. As stated above, these changes are intended merely to update and clarify the tariff for all users. This filing does not alter presently applied rates or charges and therefore will have no adverse revenue or customer impacts from what is presently transacted in the normal course of business.

It is respectfully requested that these changes become effective November 16, 2009, coincident with the effective date of the leaves submitted in the original filing.

Waiver of the requirements of 16NYCRR, §720-8 of the Commission's regulations as to newspaper publication is requested for this filing since the filing is for clarifications purposes only.
