Enclosed for filing with the Commission are an original and three (3) copies of Niagara Mohawk, d/b/a National Grid’s (“Company”) tariff amendments in compliance with the Commission’s Opinion No. 01-6, Opinion and Order Authorizing Merger and Adopting Rate Plan, issued and effective December 3, 2001 in the captioned proceeding.

Effective: January 1, 2010

Purpose of the Filing

On August 3, 2009, the Company submitted its Fourth Competitive Transition Charge Reset Compliance Filing in the above referenced proceeding (“Fourth CTC Reset Filing” or “Filing”). The purpose of this filing was to comply with Niagara Mohawk’s obligations under the Merger Rate Plan to: (i) reset its Competitive Transition Charges (“CTC”) in retail delivery rates to reflect changes in the forecast of commodity prices for the coming two years and (ii) adjust delivery rates to reflect deferral recoveries because the deferral account balance exceeded \$100 million as of June 30, 2009.

The attached leaf was inadvertently omitted from this filing and reflects a change in the hedging percentage factors for Service Classifications 1 and 2<sup>ND</sup> for the years 2010 and 2011 that were discussed in the attachments to the Filing. An Errata Notice was issued to the Secretary of the Commission on August 19, 2009 to seeking to include this leaf in the Fourth CTC Reset Filing. All Active Parties in the case were also advised at that time.

It is requested that this leaf become effective January 1, 2010, the effective date of the leaves presently before the Commission in this proceeding.

Newspaper Publication

Waiver of newspaper publication is requested for this filing since these requirements have been met with the original filing and are being made on August 13, August 20, August 27, and September 3, 2009 in accordance with the requirements of Public Service Law § 66(12)(b).
