A. Purpose of Filing

The purpose of this filing is to implement the proposed tariff effective July 1, 2009 to comply with the Commission's Order Implementing the Temporary State Assessment, issued in Case 09-M-0311 on June 19, 2009 ("Order"). The Company's proposal herein conforms to the "preferred collection method" described in the Order.

Rate design workpapers and rate calculations will be included in gas cost workpapers that are effective July 1, 2009 and filed with the Commission. Billing statements effective July 1, 2009 will include the unit rate charge and a separate statement will show the Temporary State Assessment Charge. These statements will be filed with the Commission under the Company's normal filing procedure for July 2009.

B. Billing

The Company is unable to establish a line item surcharge on customer bills in time to begin collection on July 1, 2009. Therefore, until further notice Distribution will recover the charge through its existing Delivery Adjustment Charge, as authorized by the Order (at page 19).

C. Customer Information

The Company plans to identify and briefly describe the assessment in a message printed on customer bills, or by such other means as the Company determines is suitable.

D. Newspaper Publication

The Order waives the requirement under PSL §66(12) for newspaper publication of proposed tariff amendments. Order at 37.
