Statement of Merchant Function Charge No. 2

To P.S.C. No. 214 Electricity

Effective: February 1, 2011

The above leaves and statement are being issued in compliance with Order of the Public Service Commission in Case No. 10-E-0050 issued January 24, 2011. Ordering Clause No. 1 directed the Company to file, on not less than one day's notice, tariff revisions necessary to effectuate the provisions adopted by this order to take effect on February 1, 2011. Ordering Clause No. 4 of this Order also directed the Company to file, on not less than one day's notice, further tariff revisions that are necessary to effectuate an adjustment clause mechanism to recover \$50 million of the revenue requirement associated with service company costs to take effect on February 1, 2011.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR, Appendix 7-H).
