Description of the Filing

On August 3, 2009, the Company submitted to the Commission its Fourth Competitive Transition Charge Reset Compliance Filing ("Fourth CTC Reset Filing") pursuant to Case No. 01-M-0075. This filing was submitted in compliance with the Company's obligation under its Rate Plan to reset the Competitive Transition Charges ("CTC") and delivery rates for the Company's electric and street lighting tariffs associated with years nine and ten (calendar years 2010 and 2011, respectively) of the ten-year Rate Plan. The delivery rates for 2011 were updated on January 21, 2010 in response to Information Request MMT-4 based on the Company responses to Information Request MMT-3 which was submitted to the PSC on November 18, 2009.

The purpose of this filing is to comply with Ordering Clause No. 2 of the Order issued December 21, 2009 directing the Company to file tariff amendments for the second year of the Fourth CTC Reset Filing to become effective on not less thirty days' notice on January 1, 2011.

In accordance with Ordering Clause No. 3 of this Order, the requirements of Section 66(12)(b) of the Public Service Law as to newspaper publication of these amendments is waived.
